SOUTHEAST M.L.A. NEWS

The Southeast Chapter of the Music Library Association held its annual meeting on November 15-16, 1974 at the University of South Carolina in Columbia.

Music library advocates and librarians from all regional states except Alabama and Mississippi ratified the proposed chapter by-laws and elected officers, Pauline Shaw of the University of Tennessee at Knoxville as Chairperson and Patricia Keyser of the Atlanta Public Library as Secretary-Treasurer. An executive Board, including the Chairperson, Secretary-Treasurer and past president, Kathryn P. Logan of the University of North Carolina at Chapel Hill, Valeries Burnie of Converse College at Spartanburg, South Carolina, and Dale Hudson of Florida State University at Tallahassee, was also established.

Besides the business meetings, the Columbia program featured two panel discussions. The first dealt with the perils, problems and some tried and tested solutions for the one-person show in the small college or university music library, and the second covered the trials, tribulations and some successful procedures for the public library music librarian. A special highlight of the meeting was Bill Ivey's appearance as banquet speaker. Mr. Ivey, who is President of the Country Music Foundation in Nashville, described the archival, research and publishing concerns of the organization and promised all a warm welcome to the annual meeting of the Music Library Association when it is held in Nashville in 1978.

Of primary importance and value to the individuals attending the Columbia meeting, however, was the opportunity to communicate with one another; to exchange ideas, problems, and procedures; to learn of new services, materials and procedural methods of potential use to music librarians. James Pruett, past-president of the national organization, was on hand to offer bibliographies and M.L.A. publication announcements and to communicate concerns and practices of other music libraries and chapters of the Music Library Association.

Because the chapter meeting was seen as such a helpful catalyst for communication, the assembled members felt that the first objective of the chapter should be to improve and increase communication not only among its members, but also throughout its regional constituency. Therefore, opportunities for cooperation between this chapter and state library associations will be investigated. Also, the chapter will endeavor to publish a regular communication letter dedicated to the exchange of ideas, problems, suggestions

and news of music libraries, their advocates and librarians in the southeastern region.

Unfortunately, the chapter is not so financially solvent that it can afford to disseminate such a publication free. Membership dues (\$2) have been paid in the past by meeting-goers only and have covered only past mailing expenses. To support this and future mailings of the <u>Southeast M.L.A. News</u>, the chapter requests your help. If you are interested in contributing
