



Friday offers quite a varied program, beginning with Ed Komara (SUNY, Potsdam, until recently at University of Mississippi) discussing the ins and outs of publishing for music librarians. We'll then load up in cars and vans for the trip to the Peace Center for the Performing Arts. 4. Chapter Grants

From the Chair . . .

Neil Hughes

University of Georgia

I have a conductor friend who, with mildly nauseating false modesty, frequently pronounces to the orchestra, "This baton doesn't make any sound at all ... I couldn't do this without you." (He only says that after especially long ovations or an obsequiously flattering interview.) However much such pronouncements make me want to drop the score to Schoenberg's Gurrelieder on his toes, I admit to sympathizing a little. When I write this column—and I'll confess, it's been the least pleasant of the many very pleasant duties of being Chair of SEMLA—I feel like a conductor who's rehearsing in front of the mirror. My orchestra members are all off in their various practice rooms, doing what makes SEMLA live, and what makes it get the good reviews from our fellow music librarians from outside the chapter. They really don't need me! (Those of you in the violino piccolo section, play sadly and sweetly for me here, please.) But to quote Martha Stewart, that's a good thing. So here goes: my last "From the Chair" column. Better try to make it at least a useful one!

MLA Sponsors Grant to Attend SEMLA 2001 Meeting

Applications are now being accepted for a travel grant, funded principally through the generosity of the national Music Library Association (MLA), which has awarded the Southeast Chapter \$500 for this purpose. The grant supports travel, meeting registration, hotel and subsistence expenses to attend SEMLA's annual meeting at Furman University in Greenville, SC, November 1-3, 2001. Please note that music library paraprofessionals/support professionals and library school students are among those eligible for this opportunity and are encouraged to apply.

The grant may be up to \$500 for one individual or be divided among up to three individuals. If more than one applicant is successful, additional funding beyond the amount awarded by MLA may be available from SEMLA, up to a maximum of \$250, which amount may also be divided among two or three applicants depending on the justifications provided in the applications (see II, below). Please note that the SEMLA Board may choose to award less than \$500 total, with any excess being retained by SEMLA for another, similar chapter project.

- I. Applicants must reside in one of the states or territories comprising SEMLA (Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North and South Carolina, Tennessee and Puerto Rico), and also be in at least one of the following eligible categories:
 - a) A graduate library school student (by the time of the conference in November, 2001) aspiring to become a music librarian;
 - b) A recent graduate (within one year of degree) of a graduate program in librarianship who is seeking a professional position as a music librarian;
 - c) A music librarian (holding a Master of Library Science degree or qualifications granting an equivalent status at her/his employing institution, e.g. a certified archivist with other graduate degree working extensively with music materials) in the first two years of her/his professional career, or;
 - d) A library paraprofessional/support professional working with music materials as a significant portion of his/her job responsibilities.

Applicants in categories a-c must not have attended more than one prior SEMLA meeting before applying for the grant. This restriction does not apply to paraprofessionals/support professionals.

Grant recipients will be required to sign an affidavit stating that they meet all the qualifications outlined in this announcement, including SEMLA membership (see IV, below).

- II. Applicants must submit the following to arrive by September 24, 2001:
 - 1. A letter of application which includes an explanation of the reasons for attending the SEMLA annual meeting, a justification of financial need, and a budget (the double room rate in Greenville, SC is \$69 plus tax). For those applicants currently working in libraries or archives, justification of financial need must include evidence that one has sought financial support from one's employing institution to attend the meeting and that such request was either denied or insufficiently met;
 - 2. A current résumé or vita;
 - 3. Two letters of support. Where applicable, one of the letters should be from a current supervisor.

Hotel accommodations will be funded at the double-occupancy rate, i.e. one-half of the \$69 plus tax mentioned in 1, preceding.

The grant supports travel for a SEMLA member who meets the stated criteria—see the announcement elsewhere in this issue for full details. Please note that music library support professionals, as well as library-school students or recent graduates interested in a music library career and music librarians in the first two years of their careers are all eligible provided they can demonstrate financial need. SEMLA is grateful to MLA for this support of our mutual goals, which include the ongoing goals of MLA's Plan 2001.

As I write, **Harry Eskew** (New Orleans Baptist Theological Seminary), scholar, colleague and friend, is in his last week at NOBTS. Harry retires to great accolades from fellow musicologists and librarians around the country, but better yet: he and his wife Margaret are retiring to Macon, Georgia, at least for a year or so, while Margaret finishes up her teaching commitments at Mercer! I hope all the other Georgia music librarians will join me in extending a warm welcome to Harry and Margaret, and that we'll see Harry and Margaret in their travels as they enjoy some winding-down time after decades in the service of music, librarianship, scholarship, and their faith. Harry is certainly not going gently into that or any other good night, because he's on our program in Greenville this fall, and his paper on Andrew Johnson's *Eclectic Harmony* is to appear shortly in *Notes* v. 58, no. 1.

There are other impending retirements in SEMLA, and we will announce and honor all these dear colleagues appropriately over the course of the coming year, but I'm weaseling out and handing that campaign over to my worthy successor, Sarah Dorsey, since she has demonstrated an uncanny knack for fund raising in our parent organization!

Thanks too to this year's chapter-level **Best of Chapters** nominating committee, **Rosario Barrios** (Loyola University), **Rashidah Hakeem** (University of Mississippi, Chair), and **Lynne Jaffe** (Crown Pointe Business Information Center, Atlanta). Their deadline was extremely tight this year, because of changes in the national Best of Chapters (BoC) calendar necessitated by MLA program deadlines. Even though I told Rashidah that the committee needn't come up with a nominee if they couldn't find one that fit the criteria and their own exacting standards, they astutely ignored me (my conductor analogy at work again) and promptly nominated **Alfred Lemmon** and Nancy Ruck of the Historic New Orleans Collection, who presented "The Bill Russell Jazz Collection: A Private Collection Opens to the Public" to great acclaim at our NOLA meeting last fall. Congratulations to Alfred and Nancy, and I hope that as many of us as possible will leave the slot machines and the baccarat tables long enough to go give them our support.

It's a little too soon to be doing THE "big thank-you" to Karen Jung, our Web Editor, for her wonderful work over the past three-and-a-half years—I'm going to have to leave that pleasant-but-sad task to Sarah too, since Karen will be continuing in her current role at least through our interim meeting in Las Vegas. But it does fall to me to let you know that the SEMLA Board has formed a search committee for a new Web Editor to replace her; said committee will be developing the search criteria and a position description soon. (The committee comprises Jean Finks (Stetson University.); yours truly as chair; and Karen.) This is just an early heads-up to those of you with Web development skills who may want to apply for the appointment, which is renewable annually at the pleasure of the Board for up to four years. It carries no stipend, but you will have power and glory in abundance, to say nothing of the gratitude of your fellow SEMLA members.

The brochure has been mailed! Early in July, Lynne Jaffe mailed twenty-five turquoise copies of What's the Score?: SEMLA to forty-nine different ALA-accredited schools of library and information studies.
