

Annual Meeting Preview New Orleans, October 8-10, 2009

Get ready for a good time in the Big Easy! New Orleans offers beautiful weather in October, and our conference will be held on Loyola University's campus, in the heart of gorgeous Uptown, October 8-10, 2009. Our airport is the Louis Armstrong International (MSY). With Audubon Park and Audubon Zoo just across the street from Loyola and Tulane's campuses, you're in a great location for sight-seeing. The historic streetcar line runs from this area to the French Quarter, and both of our hotels are accessible by streetcar. Tulane University is directly adjacent to Loyola; both campuses are lush, walkable, and overall beautiful, and you'll have the opportunity to visit both. Registration for this year's conference is \$30.

Two hotels are booked for our SEMLA/TMLA group, and they are both Hampton Inns. The <u>first</u> is in the Garden District, on St. Charles Ave., midway between the Quarter and Loyola's campus. The <u>other</u> is on Carondelet St., about two blocks off of Canal St., steps from the French Quarter. The rate is \$119 + 13% tax, and streetcar rides are \$1.25 each, though we will have arrangements for

shuttling you all around if you prefer. The rooms are blocked through Sunday, so if you'd like to stay an extra night and enjoy the city, you can take advantage of the conference rate that Saturday night. Gambit Weekly is a great place to view a calendar of live music and other events in New Orleans, and as you probably know, any day/night, almost any time, there is ample entertainment to enjoy!

You'll see information about the Travel Grant in this issue. Please encourage those in your libraries and schools who are eligible to apply. It's a great opportunity to get started in a very special professional organization.

With talk of New Orleans, I really must stop and welcome Charlotte Mack Hansen, newest SEMLA baby and one very good reason for making it to the meeting. By then, she'll be 3+ months old and ready to play hostess, I'm sure. Congratulations to Alicia and Eric!

This year's meeting will kick-off Thursday morning with our second annual pre-conference workshop, *Music in Libraries: Just the Basics*. Participants will choose between "Cataloging Sound Recordings" and "Music Reference" in the morning, and "Cataloging Videorecordings/DVDs" and "Music Collection Development/Acquisitions" in the afternoon. The workshop will run from 9:30 a.m. to 5:30 p.m., and in keeping with this year's spirit of cooperation, instructors from SEMLA and TMLA will join together to deliver the workshops. Additional details are available on the annual meeting website.

Our opening reception on Thursday evening will be held in our Special Collections Reading Room here in the Monroe Library (October 8, 5:30-8pm). Wine and local beers (Abita) will complement delicious local treats from our favorite caterer, Scottie's Eats.

The banquet Friday night will be held at Palace Café, on Canal St., a gorgeous building with excellent food, which used to be the site of historic Werlein Music. It's right on the French Quarter, accessible by streetcar, and close to all the live music you could want, so a post-banquet stroll to the Quarter will be easy. The banquet cost is set at \$40. Your choices for entrée include a 12-oz. ribeye, andouille-crusted fish, or a vegetarian pasta. The appetizer is a chicken and andouille gumbo; the salad is a spinach salad with housemade bacon, red onion, chopped egg, in a sherry cane vinaigrette; and dessert is the Palace Café pecan pie, Louisiana pecans baked inside a rich cane sugar custard topped with whipped cream. Vegetarian versions of the salad and soup will be provided too, don't worry!

A list of suggested tours and activities is posted at the conference website, and I hope you take advantage of some sightseeing while you're here. New Orleans is a fantastic city, offering entertainment of all kinds: music, museums, kids' activities, street performances, architecture, and of course, FOOD! Don't hesitate to ask us for any information you might need before your trip down to the Crescent City. Candidate Biographies

Secretary-Treasurer

Laurie Neuerburg works as Music Cataloging Assistant at The University of North Carolina at Chapel Hill. She holds a B.A. in Music from Iowa State University and an M.S.L.S. from The University of North Carolina at Chapel Hill. She serves on the Travel Grant Committee for the Southeast Music Library Association. Laurie is a member of the Music Library Association, Music OCLC Users Group, and the North Carolina Library Association. She was a recipient of the Kevin Freeman Travel Grant to attend the Music Library Association annual meeting in 2009. Laurie is a flutist.

Scott Phinney is Music Cataloger at the University of South Carolina, where he has worked since 2005. He holds an A.B. in Music from Davidson College, and an M.S.L.S. from the University of North Carolina at Chapel Hill, where he served as a Graduate Research Assistant in the Music Cataloging Unit. He is currently pursuing an M.M. in History at U.S.C. For the Southeast Music Library Association, he serves on the Music Library Collections Update Committee and also serves as the current Secretary/Treasurer. He has been a member of MLA since 2004 and is involved with the Authorities Subcommittee and the Archives Task Force. Scott is also a member of the Music OCLC Users Group, Online Audiovisual Catalogers, and the South Carolina Library Association. Scott performs on oboe, trombone, bassoon, and hand bells, and his research interests include remote access to music and Scandinavian piano music.

Member-at-Large

Gary R. Boye is Associate Professor and Music Librarian for the Erneston Music Library at Appalachian State University in Boone, North Carolina, where he has worked since 2000. He holds degrees in library science (M.S.L.S., University of North Carolina at Chapel Hill, 2000), musicology (Ph.D., Duke University, 1995), and guitar literature and performance (M.A., B.M., University of Georgia, 1988 and 1986). He has been a member of SEMLA and MLA since 1999, and served as Chair of the MLA Jazz & Popular Music Round Table (2002-2006) and editor of the Members Publications column for the MLA Newsletter (2002-present). Research and performing interests include early music for plucked strings, especially the Baroque guitar and lute, as well as twentieth-century country and bluegrass music. His research has been published in several journals, magazines, essay collections, and Web sites, as well as in the New Grove Dictionary of Music and Musicians, 2000 ed.

Greg Johnson has served as Associate Professor and Curator of the Blues Archive in the Department of Archives and Special Collections at the University of Mississippi since 2002. He received his Master of Library and Information Science from the University of Southern Mississippi in 2002, where he also received a Bachelor of Music in history and literature in 2000. He has served as president of the Society of Mississippi Archivists and is a member of the Music Library Association, the Association for Recorded Sound Collections, and of course SEMLA, where he is currently serving on the Program Committee. In addition to his work in the Archive, Mr. Johnson teaches a course on the role of music in changing society. He has given well over 100 presentations on the blues, civil rights, and other musical traditions. Greg has helped plan a number of programs, such as the University of Mississippi's annual Blues Symposium (2003-present), the Music of the South Conference (2005-2006), the Society of Mississippi Archivists Conference (2006-2008), and the Yocona International Folk Festival (2008-2009). Greg and his wife also perform traditional Irish music.

Educational Outreach Program

Interested in joining the illustrious group of instructors that teach music librarianship workshops in the SEMLA Chapter? Follow these easy steps:

- 1) Contact the coordinator of the Educational Outreach Program (EOP), David King, and fill out a biography/contact information form. Indicate the workshop that you are interested in teaching and your MLA chapter affiliation (SEMLA). Contact: David King kingd@carnegielibrary.org.
- 2) Become familiar with the learning objectives for the workshop that you'd like to teach. Information is available under "Learning Objectives" for each workshop at http://www.musiclibraryassoc.org/employmentanded/workshops.shtml
- 3) Attend an EOP "model workshop" that is located centrally near you, given at a SEMLA meeting or at an MLA annual meeting. Fill out the "Workshop Evaluation Form" (available from the coordinator) and submit/discuss it with the EOP coordinator.
- 4) Attend the EOP instructor meeting at the annual MLA meeting.

Qualifications:

- Member in good standing of the SEMLA chapter
- Library degree from an ALA accredited institution
- Willingness to adhere to the EOP workshop curriculum as outlined in the "Learning Objectives" for each workshop
- Employed as a librarian for at least 5 years
- Extensive knowledge in the EOP workshop topic
- Teaching experience beneficial

Other information:

- There is no mandate on the number of workshops that each EOP instructor must teach each year.
- Workshops that are given under the auspices of the Music Library Association's Educational Outreach Program (EOP) must be reported to the coordinator, and active communication with the coordinator is strongly encouraged.
- Instructors are highly encouraged to attend the continuing education workshops for EOP instructors at the MLA annual meetings.
- New instructors are often paired with experienced instructors for the first few workshops that they teach.
- Travel money is available for those instructors who travel to teach the workshops in the EOP.

Not ready to commit yet or need more information? Attend the SEMLA pre-conference workshop and sit in on a "model" workshop. There is no registration fee for those who would like to observe as a potential instructor. Contact Grover Baker (gbaker@mtsu.edu) with questions or for additional information.

The Pauline Shaw Bayne Travel Grant

 The grant supports portions of the expenses related to attending this year's annual chapter meeting in New Orleans, October 8-10, 2009.

The Travel Grant may be awarded for up to \$500. Reimbursable expenses include: conference registration; lodging for the two nights of the conference (Thursday and Friday) at one-half of the double occupancy rate; subsistence expenses at the current CONUS rate for one full day (Friday) and two partial days (Thursday and Saturday); travel by car/plane/train/bus, generally by the least expensive method. The request for reimbursement must be submitted by December 31, 2009.

The grant winner is expected to join SEMLA at the appropriate level prior to attending the conference. Dues are only \$5 for students and \$10 for others.

Supporting our colleagues' involvement in the life of the chapter is a priority! Please note that music library paraprofessionals, support staff, and library school students are eligible for this opportunity and are encouraged to apply.

Applicants must reside at the time of the meeting in one of the states or territories comprising SEMLA (Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North and South Carolina, Tennessee and Puerto Rico), and also be in at least one of the following eligible categories:

- a) A graduate library school student (by the time of the conference in October 2009), aspiring to become a music librarian;
- b) A recent graduate (within one year of degree) of a graduate program in librarianship who is seeking a professional position as a music librarian;
- c) A music librarian (holding a Master of Library Science degree or qualifications granting an equivalent status at her/his employing institution, e.g. a certified archivist with other graduate degree working extensively with music materials) in the first two years of her/his professional career, or;
- d) A library paraprofessional/support professional working with music materials as a significant portion of his/her job responsibilities.

Applicants in categories a-c must not have attended more than one prior SEMLA meeting before applying for the grant. This restriction does not apply to paraprofessionals/support professionals.

II. Applicants must submit the following to arrive by August 24, 2009:

- 1. A letter of application which includes an explanation of the reasons for attending the SEMLA annual meeting, a justification of financial need, and a budget (the single or double room rate in New Orleans, LA is \$119 plus 13% tax per night). For those applicants currently working in libraries or archives, justification of financial need must include evidence that one has sought financial support from one's employing institution to attend the meeting and that such a request was either denied or insufficiently met;
- 2. A current résumé or vita;
- 3. One letter of support. Where applicable, it should be from a current supervisor.

Award recipients who are not already members of SEMLA are expected to join prior to attending the October meeting. Join online at the SEMLA website: http://www.musiclibraryassoc.org/semla/. Annual student membership in SEMLA is currently only \$5.00; a regular membership is \$10.00. ——Continues on p.10

Hotel accommodations will be funded at the double-occupancy rate, i.e., one-half of the \$119 plus tax mentioned in II/1, preceding.
