Hotel

Attendees will stay at the Hotel Capstone on the campus of UA http://hotelcapstone.com, less than one-half mile from Gorgas Library, where our meetings will be held. The hotel rate for our conference is \$119.00 per night plus 15% tax, for a King or two Queen beds. This reduced rate will be offered Wednesday-Saturday, October 17-20. Travel

Attendees traveling by air will fly into Birmingham International Airport, approximately 60 miles

from Tuscaloosa. The meeting will begin on Thursday, October 18, with a preconference workshop, "Music in Libraries: Just the Basics," co-sponsored by MLA's Educational Outreach Program and MOUG. The preconference will be held in Gorgas Library from 9:30 a.m. to 5:30 p.m. For the morning session, workshop attendees will be able to choose between "Sound Recordings Cataloging," and "Music Reference." The afternoon sessions will include a choice between "Video Recordings Cataloging" and "Music Collection Development."

Meeting Details

Our conference kicks off on Thursday at 5:30 p.m. with registration and a reception at our hotel, with hors d'oeuvres and beverages provided by the hotel catering staff. After the reception, attendees may choose to continue on for dinner at one of numerous local restaurants. A list of restaurant options will be provided at the conference website, including several

The program on Friday morning opens with two presentations on creating digital access to collections: Lora Lennertz Jetton will describe the digitization of the Mary Celestia Parler Ozark Folklore Collection at the University of Arkansas, and Jacob Schaub will tell us about Vanderbilt University's database cataloging and tracking historic dulcimers in the Southeastern United States. After a break, there will be three presentations: Jenny Colvin will describe how she teaches the concept of copyright in her music information literacy classes; Roberta Ford will discuss an initiative at Columbus State for leasing Google Chrome books for circulation to students; and we will hear from Laura Gayle Green about her experiences as a library consultant for Mahidol University in Thailand. In the afternoon, our program continues with a presentation by Mac Nelson

Charlie Walker Collection Center for Popular Music

Center for Popular Music at Middle Tennessee State University is proud to announce that an extensive collection of materials representing the long life and career of country music singer, songwriter, and DJ Charlie Walker will soon be available to researchers. The Charlie Walker Collection is a unique and comprehensive assembly of audio/ visual materials, photographs, books serials and manuscripts that were preserved by Mr. Walker to document many of the facets of his personal and professional life. The collection also includes numerous items that feature many of the most important creative and influential figures of the post WWII country music scene, as well as items that relate to Walker's many interests and hobbies outside of music.

Charles Levi Walker, Jr. was born in Copeville, Texas on November 2, 1926 and grew up working on the familv cotton farm in Nevada, Texas where his family had relocated shortly after his birth. Walker became interested in country music from a young age and he enjoyed artists such as Jimmie Rodgers, Ernest Tubb and Bob Wills. When Walker was ten years old, he taught himself to play

mandolin. His first experience with the music business began in 1943 as a member of a Texas dance hall band. Shortly thereafter, he formed his own band, the Texas Ramblers, with his brother Ervin. In 1944, Walker joined Bill Boyd's Cowboy Ramblers where he performed at their personal appearances and radio shows. In January of 1945, Walker was drafted into U.S. Army. His service eventually took him overseas to be stationed in occupied Japan as a member of the Signal Corps. While in Japan, he formed a band and entertained the troops with country music at camp shows. Walker's Texas Ramblers soon got a job performing on the Armed Forces Radio Station where he became one of the first American disc jockeys to introduce 'hillbilly music' to Japanese listeners in Tokyo.



In addition to broadcasting, Walker enjoyed success as a performer, songwriter and recording artist throughout his long career. He recorded his first songs, "I'm Looking for Another You" and "Stolen Kisses" in 1952

In 1954 cords. he signed with Decca, recording the regional hit, "Tell Her Lies and Feed Her Candy". His first record to hit the Top 10 charts was "Only You, Only You," cowritten with Jack Newman in 1956. He also recorded on the Mercury label before signing with Columbia in 1958. His

biggest hit, "Pick Me up on Your Way Down," was also the first hit for successful song-writer Harlan Howard. Staying on the charts for 22 weeks, the song was actually the "B" side to "Two Empty Arms." Subsequent recordings included "I'll Catch You When You Fall," "When My Conscience Hurts the Most," "Who Will Buy the Wine," and "There's Where Katie Waits." Recording for the Epic label, his "Wild as a Wildcat" was a minor hit, followed by the parody, "Don't Squeeze My Sharmon," which made the Top 10 in 1967.

On August 17, 1967, Charlie Walker became a cast member of the Grand Old Opry, where he soon became an audience favorite with his witty, rowdy songs. He continued his recording career throughout the 1970s, making the charts once again with the Capitol release of "Odds and Ends" in 1974. Walker also enjoyed some success in motion pictures. In 1970, Walker appeared in the Marty Robbins film Country Music, and in 1985 he portrayed Cowboy Copas in Sweet Dreams, a biographical movie about Patsy Cline.

and Jacey Kepich on a large-scale project to digitize the Bernard Greenhouse cello music collection, a portion of the UNC Greenville Cello Music Collection, thought to be the largest collection of cello music in the world. The afternoon will conclude with a tour of UA's Hoole Library of Special Collections and the recently acquired A.J. Williams III Americana Collection.

Our Friday evening banquet will be held at Epiphany Restaurant in downtown Tuscaloosa (http://epiphanycafe.vpweb.com/). Epiphany features fresh local and regional ingredients and offers a good selection of wine, beer, and liquors. The menu will include a beef, seafood, and vegetarian option. More details about the banquet will be posted on the conference website.

The Saturday morning program focuses on our physical libraries, with a presentation and discussion led by Shelley Smith on best practices for weeding academic music collections, a presentation by Laura Williams on the redesign of the Duke Music Library, and a discussion by Lisa Hooper on understanding the library-as-community as a new method of needs assessment. After a mid-morning break, the conference will conclude with our annual business meeting, led by SEMLA president Joyce Clinkscales.

Activities in and around Tuscaloosa

If you have time to extend your stay in the Tuscaloosa area, there a several enjoyable ways to spend a day

or two. The 41st annual Kentuck Festival of the Arts will be held Saturday-Sunday, October 20-21, across the river in the historic town of Northport (http://www.kentuck.org/festival.html). The festival features work by contemporary and folk artists, including woodworkers, potters, fiber and fabric artists, quilters, and jewelers. Artists exhibiting at the festival come from all over the country, especially the Southeast. The festival is a popular event and well worth attending.

Approximately 13 miles south of Tuscaloosa is Moundville Archaeological Park, a site that was one of the main centers of Mississippian Native American culture between the 11th and 16th centuries. It is one of the most important sites of its kind in the United States. The park is administered by the University of Alabama and is a fascinating and beautiful place. The on-site museum, which has recently been renovated, features displays of artifacts excavated in the park, as well as informative audio-visual presentations.

Aside from his musical career, Charlie actively participated in a variety of sports and hobbies including golf, hunting and sport shooting. Walker was especially interested in golf and he played in about ten pro-celebrity tournaments each year as well as hosting a tournament under his own name. Walker was also a long time member of both the Shriners and Masons, eventually receiving the honor of becoming a Thirty-Third Degree Scottish Rite Mason.

Walker received many honors over the course of his long career. In 1981 he was inducted into the Country Radio Hall of Fame and in 2000 he was inducted into the Texas Country Music Hall of Fame. Walker also received numerous awards for his many accomplish-

ments in sports (golf, shooting) the National Guard, community activities as well as his long time membership in the Shriners and Masons.

The Charlie Walker collection offers a treasure trove of materials that will be of great interest to scholars in the field of American history and popular music. This collection includes over 1800 photographs featuring Walker, his friends and family and many post WWII country legends such as Ernest Tubb, Marty Robbins and others. The collection also contains over 800 original audio recordings in practically all of the formats of the last fifty years. Of special interest are the many acetate "demo" discs sent to Walker by songwriters in hopes of getting their songs recorded. These record-

Grants and Gifts

The Center for Popular Music at Middle Tennessee State University has been awarded a grant by the Tennessee Historical Records Advisory Board to produce "My Homeland": A Research Guide to Songs about Tennessee. The Center will identify and make accessible through a website a unique collection of songs about Tennessee held in its archives.

The grant will enable the Center to draw from two of its major collections of Tennessee songs, *The John S. Mitchell Collection of Tennessee Music* (1,413 sound recordings, 589 pieces of sheet music, 24 books, 1 film, and 22 posters) and *The Peter S. LaPaglia Collection* (76 select pieces of sheet music), and from complementary materials in its general holdings to develop a sophisticated, web-based research guide to music about Tennessee. Approximately 500-550 records will be digitized and incorporated into the website, with a special section on the state songs of Tennessee. Teachers will find materials appropriate for use in classrooms, and students and interested patrons will find compelling songs and images.

The University of North Carolina at Greensboro announces a \$2 million planned gift from Dr. Harold A. Schiffman and Dr. Jane Perry-Camp. The couple's gift will provide music scholarships and support the University Libraries, and the Music Library will be named for this gift.

Dr. Schiffman was born in Greensboro. "During my childhood days," Schiffman says, "the Woman's College of the University of North Carolina (now UNCG) was very important, even crucial, to my development as a musician. I attended many concerts and even had some performances of my music there. Now, UNCG has become a home for my musical archive, and I am truly grateful for the wonderful care for it from the staff of the Jackson Library and the School of Music, Theater, and Dance."

John Deal, Dean of the School of Music, Theatre and

Dance at UNCG, says, "This generous bequest from Harold Schiffman and Jane Perry-Camp, along with their previous gifts to the Jackson Library, constitute the largest gift to the School of Music, Theatre and Dance since its inception in 2010 and to the School of Music since 2001. The scholarship endowment component will provide financial assistance

to hundreds of fu-

ture music students. It is truly a transformational gift. We are tremendously indebted to Harold and Jane for their generosity."

Dean of University Libraries Rosann Bazirjian says, "I am thrilled to receive this very generous gift from Dr. Harold Schiffman and Dr. Jane Perry-Camp. The gift will allow the University Libraries to acquire, provide

access to and preserve scores, manuscripts, musical collections and other materials of importance to researchers and scholars. We cherish this gift and the opportunities it provides to grow our very special and unique collections that can be shared with students and scholars. To recognize and provide a legacy for their generosity, the Music Library will now be named The Harold Schiffman Music Library. The University Libraries are also the home of the Harold Schiffman Archive and the Egon Wellesz Contemporary Music Archive, both previously given by Harold and Jane."

Sarah Dorsey says, "I have known Jane and Harold for years. They have been coming to the UNCG "Focus on Piano Literature" events, and I think that might be where I met them. In addition to being generous, they are great musicians and delightfully friendly folk. We are blessed by this gesture and honored to name our library the Harold Schiffman Music Library. We are planning an event to celebrate the naming for October 5 from 4:00-6:00 p.m., so if any of you are in the area, feel free to drop in. The celebration will include a world premiere performance of some new choral works by Harold."

Festivals, Conferences, and Events

Harry Eskew (New Orleans Baptist Theological Seminary, retired) was among 143 members of the Sons of Jubal, the Georgia Baptist men's chorus, who travelled to China and North Korea April 10-23. They were the largest American group invited to sing at the annual spring Arts Festival in Pyongyang, the capital of North Korea. The Sons of Jubal received an award as the best large performing group at the festival. In Beijing the Sons of Jubal sang two joint concerts with music students at the Central Conservatory of Music, a leading institution for the study of music in China. Their last concert was on a Sunday afternoon at a Chinese Christian Church in Beijing, an exciting gathering

Georgia Old-Time Fiddlers Conventions: A Centennial Celebration

In celebration of the 100th anniversary of the creation of the Georgia Old-Time Fiddlers Conventions, Georgia State University Special Collections and Archives is presenting an event that highlights the significance of the conventions and their importance in the development of country music.

ings feature bare bones arrangements of the songs with Nashville's A-Team session musicians backing the singer/songwriter in simple arrangements of the song and many of these demo packages also include lyric sheets and cover letters by legendary country songwriters such as Harlan Howard.

Walker was very diligent in preserving many of his important papers throughout his life's work. His manuscript collection is comprised of approximately twelve

linear feet of documents that includes personal correspondence, fan mail and numerous business papers and contracts from his time both as a popular radio DJ and as a performer.

The processing of this collection and the creation of the finding aid is nearly complete. The finding aid should be available to visitors of the Center for Popular Music website, (http://popmusic.mtsu.edu/) in October of 2012.

SEMLA Invites Applications for the Pauline Shaw Bayne Travel Grant

I. The grant supports portions of the expenses related to attending this year's annual chapter meeting in **Tuscaloosa**, **Alabama**, **October 18-20**, **2012**.

The Travel Grant may be awarded for up to \$500. Reimbursable expenses include: conference registration; lodging for the two nights of the conference (Thursday and Friday) at one-half of the double occupancy rate; subsistence expenses ("Meals & Incidental Expenses") at the <u>CONUS</u> rate for one full day (Friday) and two partial days (Thursday and Saturday); travel by car/plane/train/bus, generally by the least expensive method. The request for reimbursement must be submitted to the SEMLA Secretary-Treasurer by **December 28, 2012**.

The grant winner is expected to join SEMLA at the appropriate level prior to attending the conference. Dues are only \$5 for students and \$10 for others.

Supporting our colleagues' involvement in the life of the chapter is a priority! Please note that music library paraprofessionals, support staff, and library school students are eligible for this opportunity and are encouraged to apply.

Applicants must reside at the time of the meeting in one of the states or territories comprising SEMLA (Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North and South Carolina, Tennessee and Puerto Rico), and also be in at least one of the following eligible categories:

- a) A graduate library school student (by the time of the conference in October 2012), aspiring to become a music librarian;
- b) A recent graduate (within one year of degree) of a graduate program in librarianship who is seeking a professional position as a music librarian;
- c) A music librarian (holding a Master of Library Science degree or qualifications granting an equivalent status at her/his employing institution, e.g. a certified archivist with other graduate degree working extensively with music materials) in the first two years of her/his professional career, or;
- d) A library paraprofessional/support professional working with music materials as a significant portion of his/her job responsibilities.

Applicants in categories a-c must not have attended more than one prior SEMLA meeting before applying for the grant. This restriction does not apply to paraprofessionals/support professionals.

II. Applicants must submit the following to arrive by August 24, 2012:

- 1. A letter of application which includes an explanation of the reasons for attending the SEMLA annual meeting, a justification of financial need, and a budget (the single or double room rate in Tuscaloosa, Alabama, is \$119 plus 15% tax per night). For those applicants currently working in libraries or archives, justification of financial need must include information that one has sought financial support from one's employing institution to attend the meeting and that such a request was either denied or insufficiently met;
- 2. A current résumé or vita;
- 3. One letter of support. Where applicable, it should be from a current supervisor.

Award recipients who are not already members of SEMLA are expected to join prior to attending the October meeting. Join online at the SEMLA website: http://semla.musiclibraryassoc.org/. Annual student membership in SEMLA is currently only \$5.00; a regular membership is \$10.00.
