Their excellent work researching best practices and considering the chapter's needs produced an impressive document. After consulting with David and making a few refinements, the Executive Board approved the policy on April 30, 2013. Having this in place is a significant step, and it makes it possible for David to impose order on the sea of documents. See David's update on page 9.

We've also investigated what guidance and assistance with the archive might be available from MLA. The response was encouraging. We're learning about evolving national policies and looking forward to future conversations. This spring we explored digitalstorage options but couldn't find a practical and affordable solution. MLA doesn't yet have digitalstorage capability either, but is working towards it. Sandy Rodriguez, MLA's newly appointed Archivist, has offered to keep us apprised of developments in this area. Only when we find a good solution will David be able to implement the digital aspects of the Collection Management Policy. In the meantime, there's plenty of important work to be done. Our intention is to post the policy on the chapter website. Any member who'd like to see the policy before that happens is welcome to contact me for a copy.

I'm looking forward to seeing everyone in October. In the meantime, have an invigorating fall!

We are planning a great conference and would encourage you to come a few days early and stay a few days after the conference to fully enjoy all that Nashville has to offer. Vanderbilt University's campus is a national arboretum and especially lovely this time of year.

HOTELS

Attendees will have a choice of places to stay both within walking distance of our meetings:

HOLIDAY INN

Holiday Inn Nashville (West End) (www.holidayinn-nashville.com/) is less than one mile from both the Heard Library (also known as the Central Library), where our Thursday and Friday meetings will be held and the Blair School of Music, where the Saturday meeting will be held. The Holiday Inn is across the street from Centennial Park and the Parthenon (www.nashville.gov/Parks-and-Recreation/Parthenon.aspx). The room rate for one King or two Queen beds is \$124/night + 15.25% tax + \$2.50

occupancy tax. This rate is confirmed for dates from October 10-12 and for dates before and after this period based on room availability. Each room includes a flatscreen TV, a minifridge, a microwave, and a coffee maker.

Additional amenities include free parking, free wi-fi Internet access, a business center in the lobby, a fitness center, an outdoor pool, a restaurant/bar, and free hotel shuttle service (by request) for any destination within a radius of 3 miles. The hotel shuttle will provide transportation to all conference venues and the downtown area. The Holiday Inn Nashville offers a breakfast buffet (\$) each morning and live music each night at 7:00 p.m. at the Commodore Grill.

In order to receive the SEMLA group hotel rate, you must reserve your room by September 10, 2013. Rooms can be reserved online or by calling the hotel at 1-877-327-4707 and telling them you are with the

SCARRITT BENNETT

Accommodations for the more frugal-minded are also available at Scarritt Bennett, a former college campus on 12 serene acres. Private rooms with shared baths are available in converted residence halls at a rate of \$50 + tax (15.25% + \$2.50). Scarritt Bennett has free wi-fi Internet access and complimentary parking. Bear in mind there are no elevators at Scarritt Bennett, but first-floor rooms can be requested. Reservations can be made by emailing reservations@scarrittbennett.org or by calling 1-615-340-7500 (toll-free: 1-866-420-5486). Scarritt Bennett is one-quarter mile from the Heard Library and just under one mile from the Blair School of Music.

PRECONFERENCE

The meeting will begin on Thursday, October 10, with a preconference workshop, "Music in Libraries: Just the Basics," co-sponsored by MLA's Educational Outreach Program and MOUG. The preconference will be held in Vanderbilt's Heard Library (also known as the Central Library) from 9:30 a.m. to 5:30 p.m. For the morning session, workshop attendees will be able to choose between "Sound Recordings Cataloging," and "Music Reference." The afternoon sessions will include a choice between "Videorecordings Cataloging" and "Music Collection Development." This year's workshop instructors are:

Our conference kicks off Thursday at 4:30 p.m. with registration and a reception starting at 5:30 at the Heard Library Community Room on Vanderbilt's campus. Guided tours of "Stage and Screen" (see page 11 of the February 2013 issue of Breve Notes, No. 97) will be offered at 5:30 and 6:00 PM followed by a reception featuring two local musicians, Paul Burch (www.paulburch.com/fr_homeplate.cfm) and Chris Scruggs (www.chrisscruggs.com/) who will introduce attendees to the music of Nashville. After the reception, attendees may choose to continue on for dinner at one of numerous local restaurants. A list of restaurant options will be provided at the conference website and distributed in the conference packet.

The program opens on Friday morning with two subjects that have become a trend in libraries for both better and worse. First, Sonia Archer-Capuzzo of the University of North Carolina-Greensboro will address the benefits and challenges of teaching music librarianship in an online environment. Afterwards, Alan Asher and Ann Lindell will discuss the factors leading to the closure of the University of Florida Music Library and the logistics behind its transfer of holdings and staff to the Architecture & Fine Arts Library. After a short break, two presentations will discuss the development of digital collections: Amy Strickland and Nancy Zavac will discuss the development of two different digital music special collections at the University of Miami, and Grover Baker of Middle Tennessee State University will speak on the digital preservation of and access to songs about Tennessee within the My Homeland Tennessee database and website.

After lunch, the presentations will continue with David Hursh of East Carolina University presenting the followup to his ethnographic study of patron activities within the East Carolina University Music Library. Following this,

Greg Johnson and John Leslie will draw upon the archival materials from the University of Mississippi's Blues Archive to illustrate Nashville's particular role in the production and dissemination of the blues.

Friday afternoon, attendees will have a choice of tours as part of the program. Attendees can select a backstage tour of the Ryman Auditorium, a national historical landmark and the mother church of country music or the Schermerhorn Symphony Center, the home of the Nashville Symphony Orchestra.

Our Friday evening banquet will be held at Sole Mio, an authentic Italian restaurant in the heart of downtown Nashville (solemionashville.com). Sole Mio specializes in handmade pastas and homemade sauces and desserts. Sole Mio is steps away from the Schermerhorn Symphony Center, Broadway Avenue (where the honky-tonks are located), and the newly constructed 16-acre Music City Center. Three choices of entrées are available to banquet attendees: Grilled Salmon, Chicken Parmesan, and Manicotti. The meal includes a salad, entrée, and dessert. A cash bar is available from 6-7 p.m. just prior to the banquet and also during the meal.

The Saturday morning program will be held in the Turner Recital Hall of the Blair School of Music, and will be a pair of lecture/recitals. First, Chris Durman and other SEMLA members will illustrate the diverse roots from which modern country music developed. Finally, Kevin Kelly and soprano Stephanie Tingler of the University of Georgia will present a lecture/recital on the evolving image of women in popular song in the early twentieth century. After a mid-morning break, the conference will conclude with our annual business meeting, led by SEMLA president Joyce Clinkscales.


ACTIVITIES IN AND AROUND NASHVILLE

SEMLA Archive Update

David Hursh, SEMLA Archivist, East Carolina University

Progress is being m a d e with regard to the future of the SEMLA archive. This year, the first archive management policy, developed by archivist David Hursh (ECU), Lisa Hooper (Tulane). Baker and Grover (Middle Tennessee State University) was approved by the SEMLA board. The policy includes plans for digitizing all existing hard

copy documents and AV materials (some of which are showing their age) as well as the management of future born-digital materials. Unfortunately, investigation into digital storage options has presented a daunting financial challenge for the organization. Fortunately, current investigations into what MLA

can do to support the digital preservation efforts of chapter archives show some hope in comparison to past inquiries in this regard. Stayed tuned for further developments with regard to the digital preservation of SEMLA's historical record!

All is not lost, however, with regard to the immediate gain from time spent developing

of materials (Governance, Business, Publications, Meetings, Historical, and, of course, Miscellaneous) with several sub-groups under each. Access will be further improved through the use of a metadata spreadsheet into which each of Ashlie's document descriptions will be entered along with a file name and archive location number for

each document. During the coming year, archivist David Hursh will, with assistance of ECU graduate assistant, examine and re-file each document according to the new organization scheme. When digitizing becomes possible, the archive will be ready for scanning and uploading, thus ensuring its continued survival for years to come. E

On August 1st, **Grover Baker** left the Center for Popular Music and began his appointment as the Visual and Performing Arts Librarian at the James E. Walker Library of Middle Tennessee State University. In this newly created tenure track faculty position, Grover will be responsible for the subject areas of music, art, theatre, and dance.

East Carolina University welcomes Christopher Holden as their new Assistant Music Librarian. Though the position is a hybrid one, Chris's main responsibility will be supervising all music cataloging activity. Chris received the MSLS from UNC-Chapel Hill in May of this year. While there, he was chosen to participate in the competitive Carolina Academic Library Associate program, and worked in the music cataloging department as part of that program. He also holds a MA degree in interdisciplinary humanities with a concentration in music from Florida State University and a BA in music and philosophy from Kenyon College in Gambier, OH.

Collections

Columbus State University Libraries recently received a significant donation of solo and duo guitar music from guitar enthusiast Mr. Dan Blaylock. For several years Mr. Blaylock purchased performance scores and compact disc recordings of primarily classical solo and duo guitar music as he traveled the world in his profession as a consultant drilling engineer. In the summer of 2011 the Schwob School of Music's Professor of Guitar, Dr. Andrew Zohn, contacted Mr. Blaylock regarding his impressive library. As a result, Mr. Blaylock generously donated his sizeable collection to the Columbus State University Music Library.

The Blaylock collection totals 5,439 scores and 623 compact discs (571 titles). This collection represents most all of the major and many lesser known composers for guitar and guitarists from all over the world. The repertoire covers several centuries, representing major sixteenth-century composers such as Joan Carlos Amat, Giovanni Foscarini, Francesco Corbetta, Robert de Visée, and Girolamo Frescobaldi

up through the present with composers such as Ned Rorem, Benjamin Britten, Elliott Carter, and Toru Takemitsu. In addition, major composers that did not specifically write for the guitar are represented


by arrangements created by other composers, arrangers, and guitarists.

A considerable number of compositions set for guitar are based on anonymous works handed down over the centuries. In addition to standard musical forms, this collection includes representations of traditional types

of music associated with Spanish/Latin American guitar such as the *choro* as well as many compositions



based on folk music from around the world and both hemispheres. Of particular interest is the large number of contemporary compositions published by the composers' national music centers. Thus far, over one-thous are cataloged and available through interlibrary loan.

SEMLA Invites Applications for the Pauline Shaw Bayne Travel Grant

The Pauline Shaw Bayne Travel Grant supports portions of the expenses related to attending this year's annual chapter meeting in Nashville, Tennessee, October 10-12, 2013.

The Travel Grant may be awarded for up to \$500. Reimbursable expenses include: conference registration; lodging for the two nights of the conference (Thursday and Friday) at one-half of the double occupancy rate; subsistence expenses ("Meals & Incidental Expenses") at the <u>CONUS</u> rate for one full day (Friday) and two partial days (Thursday and Saturday); travel by car/plane/train/bus, generally by the least expensive method. The request for reimbursement must be submitted to the SEMLA Secretary-Treasurer by **December 27, 2013**.

Supporting our colleagues' involvement in the life of the chapter is a priority! Please note that music library paraprofessionals, support staff, and library school students are eligible for this opportunity and are encouraged to apply.

Applicants must reside at the time of the meeting in one of the states or territories comprising SEMLA (Alabama, Arkansas, Florida, Georgia, Louisiana, Mississippi, North and South Carolina, Tennessee and Puerto Rico), and also be in at least one of the following eligible categories:

- a) A graduate library school student (by the time of the conference in October 2013), aspiring to become a music librarian;
- b) A recent graduate (within one year of degree) of a graduate program in librarianship who is seeking a professional position as a music librarian;
- c) A music librarian (holding a Master of Library Science degree or qualifications granting an equivalent status at her/his employing institution, e.g., a certified archivist with other graduate degree working extensively with music materials) in the first two years of her/his professional career, or;
- d) A library paraprofessional/support professional working with music materials as a significant portion of his/her job responsibilities.

Applicants in categories a-c must not have attended more than one prior SEMLA meeting before applying for the grant. This restriction does not apply to paraprofessionals/support professionals.

Applicants must submit the following to arrive by August 30, 2013:

- 1. A letter of application that includes an explanation of the reasons for attending the SEMLA annual meeting, a justification of financial need, and a budget (the single or double room rate in Nashville, Tennessee is \$124.00 plus \$21.00 tax per night). For those applicants currently working in libraries or archives, justification of financial need must include information that one has sought financial support from one's employing institution to attend the meeting and that such a request was either denied or insufficiently met;
- 2. A current résumé or vita;
- 3. One letter of support. Where applicable, it should be from a current supervisor.
